The Town of Mountain City solicits your best bid on street paving for the 2024 physical year. Project begins in <u>Spring 2024</u> and must be completed NO later than <u>June 1, 2024</u>. Any project not completed before June 1, 2024 will result in penalty of \$250.00 each day until project completion. All Bidding Contractors must be licensed, insured, and TDOT Certified.

- 3. Chestnut St: Length 675' Width 18'

- 6. Lodge ST: Length 525' Width 18'
- 7. Mary ST: Length 590' Width 20'
- 8. N Murphy ST: Length 340' Width 30'
- 9. Waylon ST: Length 590' Width 20'

2024 Patching List

1. Georgia ST: Length- 80' Width- 20' (Begin at 0" come up to 1.5" end at 0")

2024 Patching and Overlay List

- 1. Mayberry LN: Patch: Length- 55' Width 12' at 2" thick Overlay: Length- 620' Width- 15' at 1.5" thick
- 2. Mary ST: Patch: Length- 65' Width- 12' (Wedging patch various depth from 0" to 7") Overlay: Length- 590' Width- 20' at 1.5" thick

2024 Milling List

Note: All streets are to be milled for tie-ins located at the beginning and end of each map.

- 1. N Murphy ST: Mill 8 Feet wide beside sidewalk 1.5 Inch shoulder to 0 Inch center full length of map.
- 2. Wayland ST: Mill 8 Feet beside sidewalk 1.5 Inch shoulder to 0 Inch center full length of map.

2024 Paving Operation and Roadway Work Zone Requirements

- All Bidding Contractors must be licensed, insured, and TDOT Certified!
- All Flagging Operation will be A lane closure for a two-lane two-way road with two (2) certified flaggers in full Ansi TDOT approved PPE (certification cards shall be shown to the onsite inspector if he/she so asks).
- Contractors must display three DOT Approved Advance warning signs spaced 200' between each sign; on each side of the work zone (One lane Road Ahead, Be Prepared to Stop, Flagger Ahead).
- Contractors must display two bump warning signs at each milled tie-in if left open overnight.

- Contractor must construct a temporary asphalt ramp for smooth transition at each butt joint if left unpaved overnight.
- All streets must have the edges clipped and debris removed, roadway swept prior to application
 of asphalt emulsion.
- Asphalt emulsion should be applied to each street prior to paving operation at a rate of .06 +/-.01 (onsite inspector will request daily application rate at the end of each workday or project completion).
- All streets shall be paved with RS9.5C mix.
- All paved driveway, Parking Lots, and side streets must be paved back a minimum of 4'.
- All Water Valves shall be raised by contractor. Town of Mountain City does NOT supply contractor with risers.
- Manhole, and water drains will be raised by city street department during paving operation.
- ANY MANHOLE, WATER VALVE, OR STORM DRAIN COVERED BY CONTRACTOR WILL RESULT IN PAYMENT PENALTY IF NOT CORRECTED IN THE SAME WORKDAY!
- All streets shall be cleaned after completion.
- All shoulder construction will be done on an as needed basis by the town street department.

Contractors, please note each street shall be bid on a separate sheet due to the 2024 paving funding. We may accept your entire bid as a lump sum or break it down by street depending on funding.

The City roadway inspector will be onsite the whole duration of the project. Inspectors will have the right to shut down any project at any point in reference to weather conditions, job site safety, public safety, unsafe work zone flagging operation, and improper construction of asphalt procedures. Inspector will only release the project after problems have been fixed or resolved.
